3. Discussion regarding Strategy related to Collective Bargaining with Wayland Teachers Association (WTA), pursuant to M.G.L. c.30A, §21(a)(3):

The School Committee discussed the disproportionate final planning days for teachers at Loker and the Middle School as compared to the days for teachers at Claypit Hill, Happy Hollow, and the High School. Parry noted that Loker and Middle School teachers' last day would be June 25 (due to previous one-day shutdowns at each school) and teachers at Claypit Hill, Happy Hollow and the High School would be June 24. He offered a couple of proposals to address this situation, such as a flexible vacation day that could be rolled over to next year if not used this year or a non-work day while the students have a remote field day. Parry recommends that the district offer a flexible vacation day, adding that students must be in school for 185 days, and it would be difficult to get substitute coverage for a field day.

The School Committee agreed that a flexible personal/vacation day could be offered and should be used before the current school year ends or after January 1, 2021. The Committee discussed the language that may be used in the Memorandum of Agreement. Parry will notify the WTA of the School Committee's preference. WTA negotiations will hopefully resume again soon.
