Chair Jeanne Downs convened the open session at 11:35 am. WayCAM recorded the meeting and it was livestreamed via ZOOM. The meeting was conducted remotely due to the COVID-19 health pandemic and according to the revised open meeting law that allows remote participation. A roll call was taken:

Kathie Steinberg called the Finance Subcommittee meeting to order as well.

1. Discussion and Possible Vote on High School Athletics Post-Season Play:

Heath updated the Committee on competing against "red" COVID towns. For those schools that started as non-red towns when the athletic season began and then moved into the red COVID designation, it was up to that town's School Committee as to whether they continued athletic competitions. One DCL town has continued to play while "red" and their COVID numbers increasing. Heath consulted with the Wayland Health Department and last week decided not to play regular season games against that town in the medium risk sports (as identified by the MIAA) of field hockey and soccer. Wayland did compete against them in the low risk sports of cross country and golf.

Heath explained that there will be a DCL Small Championships (the COVID Cup) that will include both Wayland and the red town described above. While Wayland and that team will not face each other in the first round of the field hockey or soccer tournaments, there is a possibility they could face each other in the final round. Heath and Arthur recommended that if this occurs, Wayland not play. The Committee agreed with the recommendation. Upon a motion duly made by Ellen Grieco and seconded by Kathie Steinberg, the Committee voted unanimously (5-0) that in consideration of the Board of Health recommendation, in the event Wayland is paired against a red town in the fall tournaments for medium/high risk sports, Wayland will not take part in the competition.
