1. Discussion of All-In Return of Kindergarten the Week of February 22, 2021:

Arthur noted that in his opinion, there does not appear to have been in-school transmission of COVID-19 to date. He addressed the BOH questions regarding the kindergarten all-in return including distancing, snack and mask breaks, adequate ventilation, options for families concerned with less than six feet of distancing, evaluation once kindergarten is all-in, and a backup plan if the all-in plan does not work. John S. noted that it is worth the effort to get students back to school. Arthur noted that seven families have opted to move their kindergartners to the remote model and one family has opted to move their kindergartner from the remote model to the all-in model.

Kathie Steinberg joined the meeting at 6:10 pm.

A discussion ensued about surveillance testing and Ellen gave an update on where the testing program stands. The district has been matched with CIC Broad through the state's surveillance testing program. Dr. Mahoney noted that any spike resulting from starting the surveillance testing program needs to be viewed separately statistically from a spike resulting from the start of bringing kindergartners back all-in.

Kathie Steinberg left the meeting at 6:25 pm.

Upon a motion made by John Schuler and seconded by Brian McNamara, the Board of Health voted unanimously (5-0) to support the schools moving forward with bringing kindergartners back all-in, the surveillance testing program and keeping the Board of Health informed.
