The School Committee discussed George Harris's OML Complaint of December 16, 2014. According to the complaint, there was insufficient detail in the July 30, 2014 Executive Session minutes. Also stated in the complaint was that a subject and purpose related to a matter not reasonably anticipated by the Chair to enter Executive Session was omitted from the motion at the August 28, 2014 meeting.

Ellen distributed the draft response. As she read the response, the Committee suggested changes to the document.

Ellen commented that although she requested an extension from the Attorney General's office until February 13, 2015, she had not received a confirmation yet. In any event, Ellen will send the response by February 13th. At the February 23rd meeting, the July 30, 2014 Executive Session minutes will be amended in executive session to include more detail as discussed at the last meeting and then voted in regular session to declassify with redactions.

Upon a motion duly made by Barb Fletcher, seconded by Jeanne Downs, the School Committee <u>voted</u> to authorize Ellen Grieco to send the response related to George Harris's Open Meeting Law Complaint of December 16, 2014 to the Attorney General with the revisions discussed tonight.
