1. Executive Session:

Subsequent to a roll call vote in Regular Session on a motion made by Ellen Grieco, seconded by Barb Fletcher, the School Committee <u>voted</u> unanimously (5-0) to enter Executive Session at 11:12 p.m. for the purposes of continuing to discuss strategy with respect to collective bargaining with the Custodians, as permitted by M.G.L. c. 30A, §21(a)(3), as such discussion in open meeting may have a detrimental effect on the bargaining position of the School Committee and an Executive Session is necessary to protect the bargaining position of the School Committee, discussing strategy related to George Harris's Open Meeting Law complaints of February 28, 2014 and October 20, 2014 and the decision if the Attorney General regarding those complaints, including possible vote to declassify the Executive Session minutes referenced below related to George Harris's Open Meeting Law Complaints dated February 28, 2014 and October 20, 2014, pursuant to M.G.L. c. 30A, §21(a)(1) and M.G.L. c. 30A, §22, and approving minutes from prior executive sessions, as permitted by M.G.L. c. 30A, §22, for the following meeting: May 26, 2015. The School Committee will be joined by Paul Stein, Superintendent, Brad Crozier, Assistant Superintendent, and Diane Marobella, recording secretary.

The School Committee will reconvene in open session to conduct regular matters as noted on the meeting notice.

2. Continued Discussion of Strategy related to Negotiations with Custodians, pursuant to M.G.L. c. 30A, §21(a)(3): The School Committee reviewed a draft set of proposals to address some "housekeeping" items. Brad commented that he consulted with Ben Keefe, Susan Bottan, and the principals for their input regarding issues to address in the contract. In Ben's opinion, there isn't enough custodial staff, nor is there enough machinery that is in good working order to properly clean the buildings.

Brad asked the Committee to reach a decision fegarding the duration of the contract. A discussion ensued in terms of offering a one-year or two-year contract because of the custodial assessment that will be done by Edvocate in the near future. The concerns of the Committee and the administrators revolve around the timeline of the assessment and what

e recommendations will be regarding the custodial staff, including a possible outsourcing recommendation. Other concerns include staff morale and the custodial union not being in line with the cycle of the other unions.

Barb commented that the Board of Selectmen needs to vote to appoint a representative regarding these negotiations at its meeting on June 24th. Brad noted that his next meeting with the custodians is June 11th. The School Committee could possibly attend the Board of Selectmen's meeting on June 24th for the purpose of voting and ratifying the custodial contract.

Brad will research peer districts' custodial contracts. The School Committee will ask Susan to contact John Ledwig of Edvocate for a possible quick assessment of the level of compensation relative to comparable school districts.

Upon a motion duly made by Donna Bouchard, seconded by Barb Fletcher, the School Committee <u>voted</u> (3-2) to offer the custodians a one-year contract and the rest of the proposals discussed. A roll call vote was taken as follows.

Kathie commented that she attended training for new School Committee members at which an attorney from the Massachusetts Association of School Committees made a presentation about the Open Meeting Law. She commented at the attorney's remarks contradicted the Attorney General's decision against the School Committee in terms of executive Session minutes. The attorney stated that the School Committee does not have to release any information that affects collective bargaining.

The Committee will postpone this agenda item until June 22nd in order to obtain a clearer answer regarding this matter. Ellen and Kathie will follow up with the MASC attorney and the Attorney General's office.
