1. Public Comment There was no public comment.

2. Approve Minutes of February 13, 2014

Upon a motion made by Malcolm, seconded by Beth, it was VOTED unanimously (2-0) to approve the minutes of February 13, 2013, as written.

3. Follow-up Discussion Re: Evidence/Assessments To Be Used In The Evaluation Of The Superintendent In Connection With The Superintendent's Four Goals Approved By The SC

The subcommittee reviewed Part III and Part VI of the Massachusetts Model System for Educator Evaluation, including a review of End of Cycle and Summative Evaluation and Report: It was noted that while the mid-cycle review focuses on progress on the Superintendent's Goals for Evaluation, the End of Cycle evaluation also includes an assessment of the Superintendent's performance on the four Standards. The Subcommittee discussed the role of DESE Standards, "Elements and Evidence" in the evaluation process.

The subcommittee, with the input from Dr. Stein, selected the following to recommend to the School Committee as the six elements to be considered for the End-of-Cycle Performance Rating (Appendix B, pp B2-B8), in addition to the Assessment of Progress Toward Goals:

Needs

E. Data-Informed Decision-Making Indicator:

3. Improvement of Performance,

Effectiveness & Learning

Standard II Management & Operations

1. Recruitment & Hiring Strategies

Standard III Family & Community Engagement

C. Communication Indicator

1. Two-Way Communication

Standard IV Professional Culture

E. Shared Vision Indicator

1. Shared Vision Development

Collection of evidence was discussed as well.

4. Follow-Up Discussion re Draft Timeline for the Superintendent Evaluation Process¹

The subcommittee discussed the timing and nature of mid-cycle review, based upon the DESE implementation guide and past practice. As discussed by the SC at its last meeting, the mid-cycle review take place at the SC meeting on March 10, at which time the Superintendent will report on progress on the Superintendent's Evaluation goals. Dr. Stein reported that there will be presentations at upcoming school committee meetings which also have ties to his evaluation goals and the Standards: MCAS (4/28), RTI (5/12), Educator Evaluation and Technology (5/27) and Health (6/9).

The subcommittee recommended that the initiation of the final evaluation commence on May 27 and that it be finalized by the last meeting in June, following receipt of all the ACE reports.
